To open the files contained in this folder you will need WinZip. You can get it for free by going to:

To view these files, you will need the free Adobe Acrobat Reader, which you can download for free by going to:

Once you unzip the file, you will see a folder named **Reseller Website**, a folder named **Product Folder**, and a file named **MRRLicense.pdf** which you are reading right now.

**Lets talk about the Reseller Website folder first.**

Open it up and upload ALL of the files in your reseller website folder to YOUR server. Once you have done that, you will need to edit the index.htm file with YOUR personal information. You will also need to include your payment button/information on the index.htm file.

The next file you will need to edit is the thankyou.htm file. The download links in thankyou.htm **MUST** point to your server. **DO NOT** send your customers to my download page to download the product that they have bought from you. My download page is monitored. Only my paying customers can download from my download page. If your customer downloads my files from my site, you will be charged a \$10 download fee for EACH customer.

That's all there is to it. You are ready to start selling “**Instant Reseller Tutorials**”.
